Sam Rosmarin is one of the most successful and respected medical malpractice attorneys in New York, and the lead attorney of the Rosmarin Law Firm, which he founded in 2006. Sam has been featured in the press. A case in which his client was awarded \$8 million was featured in a New York Daily News article. That case involved a client who went into the hospital for treatment of an infection and wound up paralyzed. Sam has litigated medical malpractice cases for more than 30 years. He began his legal career with a prominent New York City medical malpractice defense firm, an experience that has served him well. Sam's earlier experience representing doctors and hospitals has enabled him to obtain many multi-million dollar settlements for his clients, and to do so in less time than might otherwise have been the case.

Sam has been representing victims in medical malpractice cases more than 15 years. He was the chairman of the medical malpractice department of a leading Rockland County litigation firm and in 1999 formed his own medical malpractice litigation firm with a partner. The success of that firm led Sam to found The Rosmarin Law Firm in 2006.

Hon. Allen Hurkin-Torres (Ret.) served as a Justice of the Supreme Court in Kings County, New York, where -- after initially sitting both as a criminal and civil trial judge -he was placed in charge of the court's entire inventory of trial-ready civil cases. In that position, he was responsible for managing one of the largest and most diverse caseloads in the United States. One of his primary responsibilities involved resolving cases through mediation, and he is credited with more than 15,000 settlements across the entire spectrum of civil cases. Added to his inventory were cases from the court's specialized parts, including all of the cases against the City of New York, the New York City Transit Authority, and all of the medical malpractice cases against the New York City Health and Hospital's Corporation. On the bench, his ability to resolve cases through mediation eliminated the court's backlog of cases. At retirement, he was acknowledged to be one of the most successful judges in New York State, recognized both for his knowledge of the law and even-handedness, as well as his unique ability to distill complex problems to their essence through a practical, common-sense approach to mediation. Currently one of the most in-demand mediators nationally, Justice Hurkin-Torres is available to mediate or arbitrate every type of civil litigation, worldwide.

Having served on the bench for nearly 20 years, Honorable Larry S. Schachner has developed an impeccable reputation for his judicial temperament, integrity and superior settlement skills.

His judicial career began in 1999 after being appointed Housing Court Judge of the Civil Court where he presided over New York City residential landlord-tenant cases which included non-payments, holdovers and proceedings involving enforcement of the Multiple Dwelling Law and Housing Maintenance Code. Four years later, Justice Schachner was elected Judge of the Civil Court where he oversaw a myriad of civil litigation including negligence, medical malpractice, contracts, commercial landlord-tenant disputes, consumer credit transactions and small claims matters. Thereafter, he served as a trial judge in the IAS Part where he adjudicated personal injury actions and issued countless decisions on pending motions.

In 2007, Hon. Schachner was appointed Acting Justice of the Supreme Court by the Chief Administrative Judge, Jonathan Lippman, where he presided over the City Part in Bronx County managing an inventory of over 5,000 tort cases. As Acting Justice, he also heard numerous pre-trial conferences to resolve issues and settle litigation, as well as ready cases for trial assignment. In 2014, Judge Schachner was elected Justice of the Supreme Court where he was assigned to the Special Trial Part in Bronx County. While in the Special Part, he was regularly engaged in settlement negotiations regarding all pending trial ready tort cases and commercial matters and rendered numerous decisions and orders on pending motions. Hon. Schachner has been rated "Highly Qualified" by the New York State Independent Judicial Election Qualification Commission.

His experience on the bench has given him a broad range of knowledge in numerous areas of the law including Labor Law, Medical Malpractice, Municipal Liability, Negligence, Premises Liability, Real Estate, Tort and Product Liability and Personal Injury.



Well regarded by practicing attorneys who appeared before him over the years, Judge Schachner has been described as: "One of the smartest judges in the Bronx and in New York City", "Extremely intelligent, he knows the law, top shelf", "Just a magnificent person", "Very proactive about pushing for settlements in cases, and that is just one of his good features. Judge Schachner was named a National Law Journal 2018 Alternative Dispute Resolution Champion, as part of a select group of only 46 nationwide. His ability to approach matters fairly and in an unbiased manner, combined with his even temperament, makes him extremely well suited to the role of arbitrator/mediator and an excellent choice for both plaintiff and defense counsel.
