THE LAW, YOUTH AND CITIZENSHIP PROGRAM 2009-10 Mini-Grants Application

The Law, Youth and Citizenship Program offers mini-grants (1) to promote development of law-related education throughout the state; (2) to further the expansion of established law studies programs; and (3) to encourage innovative work in the field of law-related education.

Priority is given to proposed programs, which are designed to:

- further the implementation of Social Studies Standards, specifically as applied to citizenship education; the relationship of the individual citizen to the local, state, national, and/or international community; the justice system; law as a unifying force in U.S. History or Global Studies; and comparative law; or
- support safe school initiatives which combine elements of school law, students' rights and responsibilities, administrative due process, and curricular legal connections; or
- support training and programs directly related to civility, citizenship, and character education; or
- support student-centered projects designed to encourage analysis on the role of the law and citizenship in America's past, present, and future; or
- facilitate students' understanding of their rights and responsibilities as citizens; or
- support learning technology initiatives in the core curriculum areas of Social Studies, English Language Arts, Civics, and Law-Related Education.

Within this scheme, proposals concerning one or more of the following will receive priority consideration: elementary and middle level education; student activities that stress involvement in decision-making through public policy debates; conflict resolution, safe schools, and violence prevention; international law; law-related education in participation in government; and law and the environment.

Representatives (teachers, department chairpersons, students, administrators, etc.) from any elementary, middle, or secondary school, school district, educational cooperative, institution of higher education, or related organization in New York State may submit a proposal for consideration. **These grants are awarded on an as needed basis.** Grant proposals shall not exceed **\$1,500**. Although funding may be requested for more than one activity, **no applicant shall receive more than one grant** award.

The LYC Grant Program is not designed to fund the purchase of classroom and/or resource materials which are "pre-packaged" or would be considered "normal" school expenses, such as character education programs or textbooks (except where a given unique resource is vital to a proposed project). The LYC Grant Program does not provide funding for honoraria for attorneys or judges. However, we will provide reimbursement for travel expenses for attorneys or judges.

The Law, Youth and Citizenship Grant Program is designed to promote the following kinds of activities:

- orientation meetings, awareness workshops, and general conferences for teachers, administrators, and/or students having as their central theme some aspect of law-related education;
- preparation of either innovative instructional materials or local newsletters on law-related subjects that meet a special need of a community/school district/education consortium;
- mock trial competitions for students in the elementary, middle, or secondary schools of a specific district or geographical area (**funds not available for statewide mock trial tournament participants or coaches**);
- innovative application of law-related learning technologies in core curriculum areas (Social Studies, English Language Arts, Civics, and Law-Related Education) to help students meet the State Standards;
- other innovative activities in law-related education that are not included above, but merit funding.

The following questions will be considered in judging the merits of each proposal:

- Is the proposed activity unique and innovative rather than duplicative of other efforts?
- Is the proposal consistent with LYC funding objectives and guidelines?
- Is a substantial need for the proposed activity demonstrated in the application?
- Are letters of support indicative of school/community support for the proposed programs?
- Is there some kind of matching contribution?
- Does the potential impact of the proposed activity go beyond a single class and/or school?
- Is the budget fiscally sound and realistic?

6. **IMPACT:** Estimate the effect that your proposal is likely to have on school curriculum, teachers, students, etc. (Where possible, cite numbers involved.)
7. **BUDGET:** Complete the budget form below. Then describe in your proposal how the money in each category will be spent.
