GENERAL COUNSEL AWARDS

The International General Counsel Awards reward the best Legal, IP and Tax departments for their management, innovation and In-House accomplishments.

Every year, more than 100 General Counsel, IP and Tax directors submit their forms to run for the Gold Award of their category.

LAW FIRM AWARDS

The Law Firm Awards are the opportunity to distinguish the top performing members of the legal community.

Each year, more than 300 leading Law Firms submit their application to the jury to compete for the Gold Award of their category.

JURY & METHODOLOGY

- Specialist jury panels, with more than 100 General Counsel in total determine the winners of each category.
- Each panel is composed of 10 jury members, General Counsel and Chief Legal Officers of Fortune 500 companies or country equivalents.
- Jury members are chosen with regard to their geographical position, M&A and IP experience and market knowledge.
- The review of application forms submitted as well as deliberation sessions allow all jury members to share their opinions and choose the winners.
- Laureates are selected on the basis of their size and growth, but also on the depth of their daily practice, experience, management and strategy.
- The names of the laureates are revealed during an official gala ceremony, recognizing all participants and rewarding the winners.
