At the TICL Section Summer 2011 Meeting held in Bar Harbor, Maine, the Executive Committee members <u>unanimously</u> agreed to utilize the funds allotted to its TICL Executive Committee Fall Meeting and instead hold a "Diversity Reception".

In November 2011, the TICL Executive Committee brought that Diversity Reception to fruition. The Reception was held at the Sheraton Hotel in Brooklyn Heights on Thursday, November 17, 2011. One and one-half hours of free Mandatory Continuing Legal Education (ethics) credits were offered in connection with the symposium. We should note that the <u>entire</u> panel for this event – including the moderators – consisted of diverse individuals.

One recurrent theme at the event was the importance of creating a personal "board of directors" to help guide an attorney on his or her path to success in the legal profession. We were gratified that a number of minority law students and newly-admitted attorneys used this opportunity to recruit leaders of our Section into their personal "boards," and we look forward to an ongoing relationship with them.

Regional Drives toward Diversity of Membership - the "TICL 2011/3000 Project"

Throughout 2011, the TICL Section continued to make efforts to diversify its membership through regionally-based membership recruitment events and through offering free Section membership in 2011 to NYSBA members that become new Section members. The TICL 2011/3000 Project has, as one of its goals, outreach to bring TICL Section membership to 3000 in these challenging economic times.

To that end, a number of recruitment events were held. In June, 2011, the Section held a wine tasting in Albany New York, to which NYSBA members in a broadly-defined region, including the Capital District, were invited. Outreach specifically targeted NYSBA members who did not belong to the Section already, and who self-identified themselves as minority/diverse.

On October 26, 2011, the TICL Section, in collaboration with the Minority Bar Association of Western New York, held a reception in Buffalo honoring NYSBA President, Vincent Doyle III. Special efforts were expended to invite non-Section members of diverse backgrounds, hailing from the western region of the State. The reception was organized by Sharon Gerstman, a member of the TICL Executive Committee, as well as the NYSBA Executive Committee, and Paul Jones, also a member of the TICL Executive Committee. (Sharon and Paul will be honored at the Annual Meeting this year, partly for their efforts to arrange the Buffalo reception with the Minority Bar Association of Western New York).

In addition, TICL would like to thank Megan O'Toole and her staff for their unwavering dedication and support in bringing the Reception together.

Law Student Events

As part of the Section's outreach plan, representatives of the Section attended a number of Law School events in 2011 in an effort to recruit our future diverse leaders. Section leaders attended a law student reception at Albany Law School in September. Students expressing an interest in the Section were put directly in touch with the Section's Diversity Chairs and Law Journal Editor, and invited to network in person at the TICL Section's "Law School for Insurance Professionals."

The Section participated in outreach to diverse law students at NYSBA events in Brooklyn Law School, New York Law School, Cardozo School of Law, SUNY Buffalo School of Law, Syracuse University School of Law and Pace University School of Law in October and November.

Tim Fennell, of the Executive Committee, spoke on behalf of the NYSBA at the Syracuse University School of Law event. As previously noted, Tim has been instrumental in leading TICL's outreach to young lawyers and law students. In addition to speaking at law schools, Tim participates on the faculty of the Young Lawyers Trial Academy and TICL is a proud sponsor of that event every year.

Upstate Membership Chair Robert Coughlin and Downstate Membership Chair Rich Kokel served as the coordinators for the October – November law school events.

Of note is that for those events occurring prior to the Diversity Reception on November 17, 2011, the attending

Executive Committee members were directed to extend invitations to the open meeting, CLE and Reception to all interested students. As a result, numerous law students attended the event and were able to network with the panelists and other attendees.

Collaboration with Minority Bar Associations.

Planning for the TICL Section's 2012 Summer Meeting in Montréal, Quebec (at an accessible and inexpensive location) includes collaboration with the leaders of New York's minority/ethnic bar associations, women's bar associations and LGBT bar associations. Outreach has already begun, with invitations to help plan a panel addressing diversity in the bar. Leaders of the Quebec and Montreal Bar Associations will also be asked to collaborate with the TICL Section.

Conclusion

TICL has tackled the Diversity Challenge set forth by the New York State Bar Association with gusto in 2011. We submit that we have not only met the metrics we set for ourselves, but exceeded our own expectations. We look forward to continued success in 2012, beginning with Part 3 of the Mentoring for Diversity Series that will take place at the Annual Meeting.

A Greater Voice: TICL Section Supports NYSBA By-Laws Amendment

The Executive Committee of the TICL Section has expressed its support for a proposed amendment to the Association's Bylaws, under which the 22 Sections of the Association would be given two at-large representatives on the Association's Executive Committee. The proposal will be up for a vote at the Annual Meeting this month. The proposed amendment will give the sections a needed voice in matters directly affecting the sections' interests and operations, including, in particular, decisions affecting the allocation of staff resources and revenue.

At the November meeting of the TICL Section's Executive Committee, the Committee expressed strong support for the proposed Bylaws amendment, provided that a concrete procedure should be put in place that fairly reflects the choices of the sections themselves and ensures balanced representation over time. The current proposal of the Section Delegates Caucus of the Association's House of Delegates addresses the concerns: The proposal offers a concrete plan for the selection of nominees by the Section Delegates of the House of Delegates, no section may have more than one representative on the Section Nominating Committee, and a section representative chosen through this process cannot be from the same section as any existing Section Executive Committee member or immediate past Section Executive Committee member.

The Section's Delegates to the NYSBA House of Delegates in 2011 have been Brendan F. Baynes (Section Treasurer), of The Baynes Law Firm, PLLC, Ravena, Gary A. Cusano, the Law Office of Gary A. Cusano PC, Yorktown Heights (Past Section Chair), and Hon. Douglas J. Hayden of Wright Risk Management (Past Section Chair).

Labor Law: Defendants' Verdict on Labor Law §240 Upheld in Ramirez v. Willow Ridge Country Club, Inc., 2011 N.Y. Slip Op. 03714 (1st Dept. 2011)

In a Labor Law §240 case, during trial, plaintiff testified that while removing wooden posts from a deck with a crow bar, he fell off of the deck through a space where a railing had been removed. In contrast, plaintiff's foreman testified that the plaintiff's accident occurred while plaintiff was straddling between an A-Frame ladder leaning against the deck railing and an extension ladder affixed to the wall of the building, and that plaintiff was pulling a gutter down at the time. According to the foreman, he admonished plaintiff to stop, but the gutter gave way, causing plaintiff to lose his balance and fall to the ground below. The jury found that defendants had violated Labor Law §240(1), but that the violation was not a substantial factor in causing the accident. Plaintiff made a motion for judgment notwithstanding the verdict, which was denied. On appeal, the Appellate Division found that a fair inference is that the jury determined that a statutory violation existed with respect to the guardrail of the deck, but that it accepted the foreman's version of the event and found that the violation was not a proximate cause of the accident. The Court further held that the trial court judge properly charged the jury that an inference could be drawn from plaintiff's refusal to waive his attorney-client privilege and allow a former paralegal at the firm that represented him in his Worker's Compensation case to testify. The Court held that it is now established that in civil proceedings an inference may be drawn against the witness because of his failure to testify or because he exercises his privilege to prevent another from testifying, whether the privilege is constitutional or statutory. Finally, the Court held that plaintiff's counsel could not use the foreman's deposition to cross-examine him as plaintiff could not establish that the deposition was sent to the witness for his review, pursuant to CPLR §3116.

Products Liability: Plaintiffs' Testimony Regarding Alleged Manufacturer of Product was Insufficient for Purposes of Product Identification; Plaintiff's Expert Affidavit was Insufficient to Defeat Motion for Summary Judgment: *Spiconardi v. Macy's East, Inc.*, 2011 W.L. 1364285 (1st Dept. 2011)

Plaintiff was injured when a shirt she was wearing caught fire as she was cooking. She brought an action against Macy's and Liz Claiborne, Inc., the alleged seller and manufacturer of the shirt. The Court held that Liz Claiborne demonstrated that the garment at issue was not contained in any of Liz Claiborne's "line books" during the relevant time period, nor was the garment contained in Fabric Utilization Reports which showed all garments manufactured and

shipped to the store where the garment was allegedly bought. The Court held that the Fabric Utilization Report could be considered on the motion for summary judgment, as it was not an existing business record subject to the motion court's discovery orders, but rather was a document created for litigation. The Court held that plaintiff failed to raise a triable issue of fact on the product identification issue, as subjective statements about where a product was purchased are not sufficient to create triable issues of fact where there is objective proof that a defendant did not sell the allegedly defective product. The Court further held that in any event, because defendant's expert tested an exemplar of the garment and found that both the "ignite time" and "burn time" met or exceed federal regulations, defendant's satisfied their burden on a motion for summary judgment. The Court found that conclusory allegations raised by plaintiff's expert, absent evidence that the product violated other relevant industry standards or accepted practices, or statistics showing the frequency of injuries arising out of the use of the product, was insufficient to create issues of fact warranting the denial of the motion.
