Vice-President's Report - Fifth Judicial District

### A. Introduction

"Each such Vice-President shall visit the various local bar associations within the judicial district and federations of such bar associations on frequent appropriate occasions, shall arrange meetings for the President with representatives of such local bar associations within the Vice-President's judicial district, and shall perform such other acts within the judicial district on behalf of the President as the President shall specifically require." NYSBA Bylaws, Art IV, § 3C (excerpt).

# B. <u>Description of Fifth Judicial District, its Local and Specialty Bar</u> Associations

The Fifth Judicial District consists of six counties in Central New York (Herkimer, Jefferson, Lewis, Oneida, Onondaga and Oswego). Approximately 45% of the population is located in the Syracuse area in Onondaga County; Oneida County has the second largest population and includes the Cities of Rome and Utica. The county seats for Onondaga, Oneida, Herkimer, and Jefferson Counties are readily accessed by car on the I-81 and I-90 axis. For Lewis and Oswego Counties, state highways off the I-81 and I-90 axis lead to Lowville and Oswego. In good weather, you can travel by car from one end of the District to the other in approximately three hours. In the winter, there are days when one cannot, and should not try to, travel to places in the District.

The county bar association in Onondaga County has @1500 members; the Oneida County Bar Association has @ 340 members. Each of these county bars has an Executive Director, an active Board of Directors, a website, a platform for pro bono services, a high school mock trial competition, a classroom speakers' program, a periodic newsletter, and a young lawyers committee. Each is an accredited CLE provider with extensive CLE programming, and each has recently started periodic, "Happy Hour", get togethers. Under local bylaws, the NYSBA Fifth District Vice-President is ex officio, a nonvoting member of the Onondaga County Bar Association Board of Directors in Syracuse.

In the other four counties (Herkimer, Jefferson, Lewis and Oswego), the county bar associations have no employees. Volunteer attorneys and judges handle all county bar association work in these four counties. Oswego County with @144 members includes the Cities of Fulton and Oswego; Jefferson County with @100 members includes the City of Watertown. Herkimer County and Lewis County have small populations and relatively few resident attorneys and judges. The six county bar associations in the District have diverse selection procedures for the NYSBA House of Delegates. Thus, not all county bar leaders in the District are members of the House of Delegates.

The Fifth District has two women's bar associations, the Central New York Women's Bar Association and the Mid-York Women's Bar Association. The District also has several, active, specialty bar associations, namely, the CNY Bankruptcy Court Bar Association, a Catholic Lawyers Guild in Syracuse, the NDNY Federal Court Bar Association, the Rome Bar Association, and active subgroups of the NYS Academy of Trial Lawyers and the NYS Trial Lawyers Association.

- 6. regional cooperation in connection with the NYSBA Report on Quality Mandated Representation approved by the HOD in March 2012.

#### **SUMMARY**
