Every year, the Section presents an outstanding program at the Annual Meeting of the New York State Bar Association. This past January was no exception as the Section's Vice-Chair, Jonathan Lupkin, organized an excellent set of presentations. The Section's Annual Luncheon is a highlight event for commercial lawyers across New York State. The luncheon had a record attendance of over 400 lawyers and judges. The Stanley H. Fuld Award was presented to the Honorable Loretta A. Preska, a District Court judge in the Southern District of New York.

One of the legacy programs of former Section Chair Lesley Friedman Rosenthal is the "Smooth Moves" program directed at involving minority lawyers in Section activities. This program has become a model for the New York State Bar Association as to how each Section can better serve the needs of minority lawyers in New York State. The CLE portion of the program was directed at practice development strategies. As the second part of the program, the Honorable George Bundy Smith Pioneer Award was presented to Elaine R. Jones, the former President and General Counsel of the NAACP Legal Defense Fund.

The Section has funded an internship in the Commercial Division directed at minority law students completing their first year of school. This year, we were pleased to present the award to Ms. Nia Kitwana Ngozi Jackson of Hofstra University School of Law.

Our Section committees put on a number of very high quality CLE programs during the past year. However, I must make a special note of the "Ethics & Civility" program, which this year celebrated its tenth anniversary, drawing hundreds of lawyers in locations across the New York State. The leadership and participation of

Section members in every region of the state made this a high-quality program in every venue.

We also develop and present numerous continuing legal education programs on topics most useful and relevant to our members' practice areas. Our more than 30 active Section committees promote research and discussion on the current issues affecting our practices. These committees produce reports that are the lifeblood of the Section, which allow us to play a crucial role in the development of commercial litigation practice to better serve our clients.

The Section's 2009-2010 officers assumed their duties on June 1, 2009. Pursuant to Article III of the Section's by-laws, Vincent J. Syracuse of Tannenbaum Helpern Syracuse & Hirschtritt LLP succeeded Peter Brown of Baker & Hostetler as Section Chair, and Jonathan D. Lupkin of Flemming Zulak Williamson Zauderer LLP succeeded Mr. Syracuse as Section Chair-Elect. David

H. Tennant of Nixon Peabody LLP was elected Section Vice-Chair, and Paul D. Sarkozi of Tannenbaum Helpern Syracuse & Hirschtritt LLP was elected Section Treasurer, at the Section's Annual meeting on January 28, 2009. Deborah Kaplan of Baker & Hostetler was re-elected Section Secretary.

David H. Tennant is a partner with Nixon Peabody LLP (Rochester, New York) where his practice includes complex commercial litigation and appellate matters. He is a founding member of his firm's appellate team. Mr. Tennant serves on the Executive Committee for the Commercial and Federal Litigation Section, co-chairs the Section's Committee on Appellate Practice, and is a member of the Section's Committee on the Commercial Division. He serves as the Section's liaison to the Commercial Division for the Seventh Judicial District. Mr. Tennant is a frequent lecturer and writer on appellate practice and ethics, serves as program chair for the NYSBA Ethics & Civility program in Rochester, and moderated the firstever Commercial Division CLE involving all three Commercial Division Justices from Syracuse, Rochester, and Buffalo. Mr. Tennant recently served as a CLE presenter to Commercial Division justices and judicial staff at the New York State Judicial Institute at Pace University. He is a past chair of the NYSBA's Committee on Mass Disaster Response, on which he remains active, with his most recent committee service helping families affected by the mass shootings at the American Civic Association in Binghamton, New York.

Paul Sarkozi is a partner at Tannenbaum Helpern Syracuse & Hirschtritt LLP in New York City and a member of its litigation and alternate dispute resolution practice group. Mr. Sarkozi has been a member of the Section's Executive Committee since 2006, is the Chair of the Section's Committee on the Commercial Division, and is the former Co-chair of the Section's Commercial Division Law Report Committee. A graduate of Yale University and Harvard Law School, Mr. Sarkozi's practice focuses on business litigation and arbitration, both in the United States and internationally, with a particular concentration on disputes in New York's Commercial Division. His experience covers a broad range of matters involving

Mr. Sarkozi has also played an active role in the Section's CLE offerings. In 2009, he organized and coordinated several programs for the Section's Spring Meeting. Third Annual "Smooth Moves" CLE Program for Attorneys of Color

On March 25, 2009, the Commercial and Federal Litigation Section presented its third annual "Smooth Moves" program at Lincoln Center for the Performing Arts in New York City. Smooth Moves is the Section's premiere diversity event, organized annually to attract attorneys of color to more active participation within the Section. This year's event, which was hosted by the Section at no charge, attracted more than 200 participants from all sectors of the profession—law firms large and small, in-house legal departments, government, and not-for-profit organizations.

Since its inception in 2007, the event has included both a CLE program and a networking reception, culminating in the presentation of the Section's Honorable George Bundy Smith Pioneer Award. The Pioneer Award is given each year to a litigator of color whose career accomplishments exemplify those of the retired Court of Appeals judge for whom the award is named: legal excellence, community involvement, and mentoring. The award was established by the Section in recognition of Judge Smith's work in the civil rights movement, and his 30 years of public service in the New York judiciary, including 14 years as an associate judge of the Court of Appeals. The Section also awards a Minority Law Student Summer Fellowship at the event to a first year law student, who spends the summer working in the chambers of a Commercial Division justice. The Fellowship is funded by the Section and administered by The New York Bar Foundation.

The CLE program this year was entitled "Business

Development Strategies for Attorneys of Color in Challenging Economic Times" and featured an absolutely stellar panel of practitioners: Andrew T. Hahn, Sr., Partner, Seyfarth Shaw LLP and president of the National Asian Pacific American Bar Association; James E. Johnson, Partner, Debevoise & Plimpton LLP; Elizabeth D. Moore, Partner, Nixon Peabody LLP; Elpidio "PD" Villarreal, Director of Litigation for New Jersey-based Schering-Plough Corporation; and Theodore V. Wells, Jr., Partner, Paul, Weiss, Rifkind, Wharton & Garrison LLP. Loretta E. Lynch, Partner, Hogan & Hartson LLP, and formerly the U.S.

Attorney for the Eastern District of New York, was the moderator for the panel's discussion, which focused on imparting practical advice for attorneys of color on effective techniques toward building a client base in a down economy, including developing subject matter expertise, mining business contacts, marketing oneself within one's own law firm, and other ways to proactively translate contacts into lucrative business.

Elaine R. Jones, the President and Director-Counsel Emeritus of the NAACP Legal Defense and Educational Fund (LDF), was this year's recipient of the George Bundy Smith Pioneer Award. "During her remarkable career, Elaine Jones worked determinedly to fight for justice and equality. She is a dynamic leader and trailblazer, embodying the pioneering example set by retired Court of Appeals Judge George Bundy Smith," said Peter Brown, the Section's 2008-09 Chair.

Ms. Jones received her undergraduate degree from Howard University, and then became the first black woman to enroll in the University of Virginia School of Law and, ultimately, the school's first African-American graduate. Ms. Jones' career continued to encompass a series of pioneering "firsts," as she became one of the first African-Americans to serve in Turkey as part of the Peace Corps; the first African-American to be elected to the American Bar Association's Board of Governors; and the first woman to lead the acclaimed and historic NAACP LDF, which was founded by Thurgood Marshall. Ms. Jones joined the NAACP LDF as a staff attorney in 1970, defending death row inmates and taking on countless civ-

il rights cases. She also served as counsel of record in the landmark Supreme Court death penalty case *Furman v. Georgia*. During her nearly 30-year career at NAACP LDF, she played an integral role in shaping LDF's contributions to the Voting Rights Act Amendments of 1982 and the Civil Rights Act of 1991. Ms. Jones also received the Eleanor Roosevelt Human Rights Award from President Clinton in 2000.

After a stirring and inspiring tribute to her life and career, Ms. Jones was presented with the Pioneer Award by her immediate successor at NAACP LDF, Ted Shaw, who is currently a

Professor at Columbia University School of Law and Of Counsel to Fulbright & Jaworski LLP. During his presentation, Mr. Shaw stated,

[Elaine] has this life force. And I thank God that that life force has been given to the cause of human rights, racial and social justice, [and] to making our country better. She is one of the great Americans. And George Bundy Smith is one of the great Americans. To link them even more closely through the presentation of this award is a singular honor.

Judge George Bundy Smith also noted at the awards presentation,

I am delighted that tonight's awardee is Elaine Jones. She was a legend at the Legal Defense Fund.... So, I am particularly honored that she is going to accept this award this evening.... And, again, we still have an awful lot of work to do. But, as long as we have leadership like Elaine Jones gave to America, America is in good hands.

In accepting the award, Ms. Jones noted,

[A]ll of the problems of past history of social and economic significance find their way into the court. And so we, as lawyers, help establish the rules. What are the guideposts? What is the gateway? And, therefore, that is our charge. Our public service is critical to us . . . I thank you, Judge Smith. I thank you New York State Bar, Commercial and Federal Litigation Section, for embracing me. I thank all of you for coming out and this show of support. And the work goes on.

The past recipients of the Section's Pioneer Award are Hon. George Bundy Smith of New York (Chadbourne


The Commercial and Federal Litigation Section Goes to the Hall of Fame and Hits a Home Run




year's success, in partnership with the Young Lawyers





Notes of the Section's Executive Committee Meetings

December 9, 2008

Guest speaker the Hon. Ira B. Warshawsky, Justice of the Supreme Court, Commercial Division, Nassau County, shared with the Section his thoughts on current trends in litigation, from electronic discovery to summary judgment motions, articulated several of his own personal preferences with respect to litigations and trials, and suggested cost-saving measures of which parties might avail themselves, such as sharing litigation databases.

The Executive Committee received a report of the Committee on Class Action on the differences in the circuits' approaches to satisfying Rule 23's class certification requirements. The Executive Committee approved the Committee on Federal Procedure's reports on the Advisory Committee on Civil Rules' proposed changes to Fed. R. Civ. P. 26 and 56.

February 10, 2009

Guest speaker John W. Moscow, Partner, Baker & Hostetler LLP, shared with the Executive Committee his experience at the New York County District Attorney's Office investigating and prosecuting the Bank of Credit and Commerce International (BCCI) for its role in one of the largest "Ponzi schemes" in history. He provided a historical overview of both the origin of BCCI and the Government's investigation of BCCI.

The Executive Committee discussed a draft report of the NYSBA Task Force on Privacy. The Executive Committee also discussed plans for upcoming Section events and programs.



March 10, 2009

Guest speaker Simeon H. Baum, Chair of the NYSBA Dispute Resolution Section, engaged the Section in an interactive discussion of various models of dispute resolution, including the merits of joint sessions versus caucus. Mr. Baum also distributed two reports by the Dispute Resolution Section, one regarding the Arbitration Fairness Act and one concerning arbitration discovery in domestic commercial cases.

The Executive Committee discussed plans for the "Smooth Moves" program and the Spring Meeting.

April 7, 2009

Guest Speaker the Honorable Justice Herman Cahn, recently retired Justice of the Supreme Court, Commercial Division, New York County, discussed various issues affecting the Commercial Division, including adjusting judicial salaries and continuing the New York State Supreme Court Commercial Division's judicial internship program. Justice Cahn posited mediation as a valuable tool, and the Executive Committee discussed the merits of various methods of mediation, as well as which types of cases ought to be heard by the Commercial Division.

The Executive Committee discussed upcoming Section events and programs and the possible filing of an amicus brief in a case certified to the New York State Court of Appeals involving the issue of whether, as a matter of law, a party commits champerty when, as the holder of a defaulted debt obligation, it acquires the right to pursue a lawsuit against a third party in order to collect more damages through that litigation than it had demanded in settlement from the assignor.
