Representative Cases

In 2001 the New York Law Journal reported a verdict of \$4.8 million in a case tried by Mr. Anderson, as the highest products liability verdict in upstate New York in 2000.
\$3.0 million verdict in a gas explosion case tried in Federal Court in Albany, New York.
\$1.75 million settlement for an Albany man who sustained serious injury while riding an all terrain vehicle.
\$1.5 million arbitration award for a Fort Johnson woman who sustained serious neck and back injury after falling on an icy step.
\$1.25 million settlement against a local hospital for the death of a 35 year old married man with young children in a medical negligence case.
