To the Members of the Executive Committee of the New York State Bar Association:

On behalf of the Local and State Government Law Section, I wish to laud the tremendous efforts of the President's Committee on Access to Justice in proposing a model *pro bono* policy for attorneys in state and federal government which was adopted by that Committee on April 4, 2016. Our Section also wishes to express its appreciation to the Executive Committee of the State Bar for the opportunity to review and comment on the report.

Our Section's Executive Committee has devoted a number of hours to reviewing the proposed policy, and has discussed the matter in monthly conference calls and at our Executive Committee meeting on May 20, 2016 in White Plains. I must report, however, that while we support, in concept, encouraging government attorneys to provide *pro bono* services, given the complex and unique nature of government service and employment, we must be mindful that the implementation of a model *pro bono* policy presents a myriad of issues not encountered by private law firms and corporate law departments, and subjects the government to a higher level of scrutiny and responsibility to the public at large, particularly where government decision making is necessarily involved and taxpayer resources are at stake.

As you know, our Section, formerly the Municipal Law Section, had been primarily focused upon local government practice and has only recently embraced the addition of state attorneys to our ranks. Our Executive Committee believes that it is premature at this juncture to be able to fully analyze the impact of the proposed model *pro bono* policy without the benefit of having a number of state government attorneys to offer their valuable input. Preliminarily, however, our Executive Committee has expressed its concern that a number of the recommendations in the proposed model policy may potentially allow, require and/or encourage activity by a state agency and/or its attorneys that may be either prohibited by State law or otherwise unauthorized absent a specific legislative grant of authority. Furthermore, it is a consensus of our Executive Committee that our Section, with the anticipated addition of new state attorney members, would be better suited and possess the expertise to devise a pragmatic and workable model *pro bono* policy that may be used by local and state governments.

As such, our Section and its Executive Committee will continue to strive toward developing such an approach in the hope of providing a realistic and workable proposal to meet the intended goal of the Golden Gavel model in a manner that is consistent with the constitutional and statutory restraints on the use of state and local government personnel, time and resources.
