Keynote Speaker:

Andrew Revkin, environmental journalist, blogger, teacher and activist is a senior reporter for climate and related issues at ProPublica.org. He joined the prize-winning public-interest newsroom after 21 years of writing for The New York Times, most recently through his Dot Earth blog for the Opinion section, and six years teaching at Pace University. He began writing on climate change in the 1980s and has never stopped. He has written acclaimed and award-winning books on global warming, the changing Arctic and the assault on the Amazon rain forest, as well as three book chapters on science communication. Revkin is among those credited with developing the idea that humans, through growing impacts on Earth's climate and other critical systems, had created a "geological age of our own making," known increasingly as the Anthropocene. As a result, he was a member of the "Anthropocene" Working Group from 2010 to 2016.
