With state vote in sight, Bar aims to inform the public


House of Delegates says 'yes' to Constitutional Convention

After a 111–28 House of Delegates vote (with one abstention) June 17 in favor of supporting a Constitutional Convention, the State Bar plans to educate New York voters about the current Constitution and inform them of ways a potential convention could affect everything from the Adirondack and Catskill "forever-wild" provisions to the structure of the state's judiciary.

A Constitutional Convention "is a once-in-ageneration opportunity-a rare chance for direct democracy—that our Constitution gives the voters to potentially re-invent their state government, if they so choose," said Henry M. Greenberg of Albany (Greenberg Traurig LLP), who presented a report calling for support of a convention, prior to the House vote.

'We have had, in our history, four Constitu-





Legal profession is obligated to cure injustices within its power, Gerstman says

Calling her the "best and the brightest among all of us in New York State and nationwide," Associate Judge of the Court of Appeals Eugene M. Fahey ceremoniously swore in Sharon Stern Gerstman of Buffalo as the State Bar's 120th president on June 17.

"To be a leader in the New York State Bar Association and become president is to be a leader of the national legal profession," said Fahey,

also of Buffalo, during the event, held during the House of Delegates meeting in Cooperstown.

Gerstman, speaking after being sworn in, said she believes that, "as bar leaders, lawyers and members of a civilized society, we have an obligation to cure whatever injustices are within our power to cure."

She recalled "how lucky" she is to have been "born free, an American, to parents who value education and public service, and

for a girl growing up in the '50s and '60s, to have been taught that it was good to be smart, even in math and science."

She said she has had the good fortune of teachers who opened doors for her, deans who took a chance on her and law firms, judges and bar leaders who mentored and welcomed her.

"I look at the trajectory that brought me to this place as a wife, a mother, a mother-in-law and a grandmother-

Free guide clarifies laws about service animals

A new guide interprets the various federal, state and local laws that address the use of service animals in different ways and contexts.

Noting that the varying laws often result in confusion, better understanding of laws regarding service animals would promote respect for both the laws and those who utilize service animals.

The guide was produced by a joint task force of the State Bar and the New York City Bar Association with both groups' committees on disability law.

Approved by the State Bar's Executive Committee on March 31, the guide covers rights by location and context, including public accommodations, transportation, employment, housing and training. It also includes information on claims under federal, state and local laws.

Fox also serves on the Board of Directors of the Orange County Bar Association, and on the Advisory Board of the Food Bank of the Hudson Valley. He obtained degrees from Bucknell University and Columbia University School of Law.

Syracuse study aims to reduce biases against LGBT+ and disabled attorneys

Syracuse University will be the site of an American Bar Association (ABA) study to identify biases encountered by LGBT+ and/or disabled attorneys in the legal profession.

The study, which will be conducted at the school's Burton Blatt Institute, which focuses on advancing civic, economic and social participation

> of people with disabilities, will help develop and implement strategies for more inclusiveness.

> "This study is integral to the ABA's continuing efforts to promote the full and equal participation of all diverse persons, including LGBT+ lawyers and lawyers with disabilities, in the association and the legal profession as a whole," said ABA President Linda Klein.

> The study is part of the ABA Pathway to the Profession Project, which grew out of the ABA Diversity and Inclusion 360 Commission. It will be used to develop strategies for more inclusiveness, enabling "the ABA to make a positive impact on the U.S. legal profes-

sion and on the lives and careers of LGBT+ lawyers and/or lawyers with disabilities," said Peter Blanck, law professor and chair of the Burton Blatt Institute, who is also lead investigator of the study.

Cannabis committee created

With more than 30 states (including New York) permitting the use of cannabis for some purposes and eight states and the District of Columbia permitting its recreation use, a new State Bar committee will study and recommend measures—including legislation and administrative action—regarding a number of topics related to cannabis.

The committee was approved by the State Bar's Executive Committee following a report on the subject presented by Brian J. Malkin of Washington, D.C. (Arent Fox LLP), chair of the Food, Drug and Cosmetic Law Section.

"This committee seeks to help NYSBA lawyers give their clients better advice through sharing educational resources, and otherwise helping New York set the highest possible legal and business (including advice to medical professions) standards for legalized cannabis products," according to a nearly three-page proposed mission statement presented to the Executive Committee. •

Root/Stimson Award

The award, given by the State Bar's Committee on Annual Award, honors an attorney for exemplary

community service. It is named for distinguished lawyers Elihu Root and Henry Stimson to honor their commitment to public service.

Root served in President Theodore Roosevelt's administration as secretary of state, received the Nobel Peace Prize and was a president of the New York State Bar Association.

Stimson served as

secretary of war under President William Howard Taft, President Franklin D. Roosevelt and President Harry S. Truman. He also served as secretary of state under President Herbert Hoover.
