WHEREAS, the Members wish to set forth their agreement as to how the business and affairs of the Company shall be managed and their rights and obligations with respect to the Company;

NOW, THEREFORE, in consideration of the mutual promises contained in this Agreement, the parties hereby agree as follows:

#### **ARTICLE I**

## Formation and Business of the Company

- 1.1 <u>Formation</u>. The Company was organized on {}, {}, in accordance with and pursuant to the Act. {Note that initial operating agreement should be executed within 90 days after filing of the Articles of Organization.}
