Many school district faculty members and administrators supported and even encouraged this movement and its planned walkouts. Other districts imposed discipline upon their students for their actions of “materially and substantially” disrupting their school districts’ educational process.

Whether you are an attorney, teacher, administrator or a person who is simply interested in this topic, come and explore the contours of student and faculty member protected free speech rights. Join an interactive discussion on how complex first amendment principles can be translated into best practices for the operation of school districts.
