# Who are we?

## New York State Bar Association and the International Section

The New York State Bar Association's International Section is comprised of almost 1,900 members, approximately half of whom are located outside the United States. The Section has a number of committees covering an array of international subjects, such as arbitration and ADR, banking and finance, cross-border litigation, data security, human rights, immigration, the environment, insolvencies and reorganization, tax, transportation and trade, and trusts and estates, to name just a few. Moreover, the Section is unique in having numerous chapters around the world. These chapters are comprised of members of the Section, are mostly organized by country, and have regular meetings and hold receptions and seminars.

Typically, over 200 Section members and other participants from around the globe attend the conferences we hold in the autumn outside the United States, and we expect Tokyo will be no different.



## What is the Global Conference?

Each year, NYSBA's International Section hosts a conference in a different city outside of the United States to provide American and foreign colleagues the opportunity to meet, network, and expand their international practices. Our most recent conferences have been held in Montréal (2018), Antigua, Guatemala (2017), Paris (2016), São Paulo (2015), Vienna (2014), Hanoi (2013), Lisbon (2012), Panama (2011), and Sydney (2010). This year, the conference will consist of three days of Continuing Legal Education (CLE) panels and plenaries, including a Mock International Arbitration, an Arbitration Plenary featuring representatives of the top international arbitration organization, an ethics panel, and various other hot topics in international law. The meeting also offers networking opportunities in the form of extended breaks, luncheons, receptions, dinners, including our traditional gala dinner, and social and cultural events.

## What will I get from participating?

**The Global Conference offers participants opportunities to:**

- Attend programs with faculty foremost in their fields who will address both legal and professional issues and their impact on international practices;
- Exchange ideas and strategies with other professionals on an informal basis; and
- Meet and network with key players from leading international firms and businesses who share common interests and concerns relating to international legal practice.

The Arbitration Plenary will feature representatives of the AIDA Reinsurance and Insurance Arbitration Society (ARIAS) - U.S., Arbitration Ireland, the Hong Kong International Arbitration Centre, the International Centre for Dispute Resolution, the International Chamber of Commerce, the Korean Council for International Arbitration, JAMS International, the Japan International Dispute Resolution Center, the Philippine International Center for Conflict Resolution, the Singapore International Arbitration Centre, and the Stockholm Chamber of Commerce, led by practitioners Yoshimasa Furuta of Anderson Mori & Tomotsune (Tokyo), Jay G. Safer of Wollmuth Maher & Deutsch LLP (New York), and Ron Soffer, Soffer Advocats (Paris).

The Mock Arbitration will feature top international arbitration practitioners who, in two mock arbitrations, will explain and demonstrate best practices for international arbitral advocacy, and a workshop will demonstrate how practitioners may most effectively advocate for their clients amid a diversity of cultures, legal traditions, and ethical requirements. The General Counsel Plenary will be a discussion by in-house counsel of prominent international business about the cross-border and transnational legal issues that concern them most. The Human Rights Plenary will focus on marriage equality, diversity and inclusion, and human trafficking; one of the Co-Chairs is Prof. Osamu Arakaki, Professor of International Law at International Christian University (ICU) in Tokyo.
