Leona Beane is Professor Emeritus of Law at Baruch College (City University) in New York City, where she taught for 21 years. Professor Beane received her B.B.A. and M.B.A. from the City College of New York, M.S. from Columbia University and J.D. from New York Law School. She has been a practicing attorney involved in estates, guardians and A.D.R., and is an active member of several bar associations.
