The legal fraternity was introduced to the SMU School of Law in March 2007. The school opened its doors in July 2007 to its pioneer batch of 107 students with Professor Michael Furmston as its first Dean.

"2007 was my fiftieth year of law teaching. This period has included many exciting events but none more so than starting a new law school. Doing so in Singapore was a striking coincidence because years ago Lee Sheridan, the first Dean of the NUS Law School and I had been colleagues in Belfast. Complacency is no doubt the greatest sin of old lawyers but I dare to think we did some things right."

The School of Law achieved numerous milestones in its first decade under the leadership of its first Dean, Professor Michael Furmston, and second Dean, **Professor Yeo Tiong Min SC** (honoris causa). Starting with an initial intake of 107 LLB students in 2007, the School progressively increased its annual intake to 180 students in 2017. The School expanded its degree offerings by launching the Juris Doctor programme in 2009 and the Master of Laws programme in 2011.

The School offers exchange opportunities to a broad selection of law schools worldwide and conducts regular overseas study missions to both common law and civil law jurisdictions. The School complements its distinctive legal curricula with opportunities for students to develop practical legal skills.



To instil a sense of social responsibility among our students, the Pro Bono Centre was set up in 2013 to run a pro bono programme for all LLB and JD students.

The Centre for Cross-Border Commercial Law in Asia (CEBCLA) and the Applied Research Centre for Intellectual Assets and the Law in Asia (ARCIALA) were established in 2014 and 2015 respectively.

The Law School provides a structured programme that has enabled its students to excel in international mooting competitions.
