Since the Empire State Counsel® Program was launched in 2006 by former president Mark Alcott more than **5000** Association members have earned this honorary designation. Collectively our members have provided more than **660,000** hours of free legal services!

Our members' generosity helped to ensure that equal access to the justice system is not merely a lofty ideal, but a tangible reality. Thanks to our members' efforts foreclosed homeowners, evicted tenants, disabled children, and the victims of consumer fraud had meaningful access to justice.
