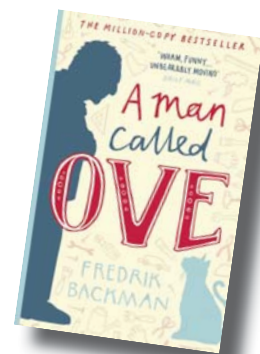
## GOLF TOURNAMENT INFORMATION:

The title character in Fredrik Backman's best-selling novel, *A Man Called Ove*, is getting older. He is "the kind of man who points at people he dislikes as if they were burglars caught outside his bedroom window. He has staunch principles, strict routines, and a short fuse. People in Ove's neighborhood call him "the bitter neighbor from hell." But behind Ove's cranky exterior lies a story and a sadness. When an accident-prone young couple with two young daughters moves in next door and accidentally flatten Ove's mailbox one November morning, overturning his well-ordered routine, it is the spark in a surprising, enlivening chain of events—featuring unkempt cats, unexpected friendships, arrogant bureaucrats, several trips to the hospital, and the ancient art of backing up a U-Haul. Swept along in the tide, Ove is forced to change and learn to understand his neighbors and the modern times into which he has been grudgingly dragged. But as his neighbors learn more about the reasons behind Ove's grumpy façade, they must also band together to protect each other and their neighborhood in a struggle that will leave no one, including Ove, unchanged."
