PRESIDENT'S MESSAGE

Pro bono publico is at the very heart of the New York State Bar Association. Our stationery, website and publications all bear the quote: "Do the Public Good." It pervades our legislative priorities, when we fight for changes which will better the justice system, funding for the provision of civil legal services, and fully funded representation for criminal defendants and for all citizens who need assistance to receive basic needs. The Association also funds many programs which enable our members to provide legal services pro bono to those who need it

most. Our Foundation funds over 100 legal service providers.

Our Rules of Professional Conduct encourage all lawyers to provide pro bono representation, and set 50 hours as an aspirational goal. While many of us have the best intentions to meet this aspiration, the lawyers we recognize and honor today have matched their intentions with action which not only meets, but often exceeds, this goal. In 2007, then-President Mark Alcott created the Empire State Counsel® Program, to recognize the extraordinary work these lawyers do, to increase awareness of the intense need for pro bono representation, and to encourage more attorneys to meet the aspirational goal.

Since the program's inception, thousands of attorneys have met the criteria and have been designated Empire State Counsel®. Today we honor all of them for the great good that they do, whether at the federal or local level, on behalf of immigrants or citizens, to protect civil rights or to ensure that basic needs are met. Of these tireless attorneys, we choose a few representative attorneys, who have done extraordinary work, and a few representative law firms who have dedicated resources that make such a large impact.

Our 2017 Outstanding Pro Bono Volunteers are Benjamin Ostrer and Caroline Heller. Ben has contributed hundreds of hours at both the trial level and appellate level in the defense of criminal defendants. In addition to all of the "hands on" representation, he also finds the time to share his expertise with other attorneys, either by editing "Atticus," a publication of the New York State Association of Criminal Defense Lawyers, or as a panelist at numerous CLE programs. Pro bono is a way of life for Ben – he has been recognized many times for his contributions, including with the 2016 Charles Crimi award from NYSBA's Criminal Justice Section.

Caroline has not only contributed hundreds of hours in representing special needs children in proceedings for the enforcement of their educational rights, but as pro bono coordinator of Greenberg Traurig's New York office, she has

energized the lawyers in her firm to take on large pro bono projects, including the adoption of homeless youth shelters and training for representing refugees. Pro bono is a way of life for Caroline, too.

We also recognize the excellent efforts of law firms throughout the state. These efforts are essential in assisting and encouraging their lawyers to perform pro bono representation. We honor three within New York City: Skadden Arps, Proskauer Rose and Willkie Farr & Gallagher; and three outside the city: Barclay Damon, Phillips Lytle and Nixon Peabody. Their pro bono practices are described further in this brochure.

We are presenting for the first time two new awards to honor the pro bono work of Free Legal AnswersTM volunteers. New York's Free Legal AnswersTM site (ny.freelegalanswers.org) was launched in August 2016 as part of the American Bar Association's nationwide Free Legal AnswersTM project. It allows volunteer attorneys to answer low-income New Yorkers' basic civil legal questions on a limited scope basis online. Today, we honor Phillip Hurwitz, a Rochester-based attorney who has answered over 70 questions on Free Legal AnswersTM, for having the most significant impact on New York's Free Legal AnswersTM clients in the past year. We also honor Barclay Damon as the firm that has the most attorneys and partners signed up for Free Legal AnswersTM.

This year, we are so honored to have the Honorable Janet DiFiore, Chief Judge of the Court of Appeals, as our keynote speaker. Judge DiFiore has tirelessly advocated for increased funding of civil legal services, and has dedicated her life to public service. Having her with us underscores the support that our Courts give to the pro bono efforts of all attorneys and demonstrates the importance of our goal: Justice for All.

Chief Judge Janet DiFiore

Chief Judge Janet DiFiore has devoted her career to the fair administration of justice, both as a judge and prosecutor. Throughout her career, she has brought to her work a combination of bold and effective ideas, a willingness to work extensively with colleagues and partner agencies, and a non-partisan approach to problem-solving which emphasizes collaborative effort and shared credit.

Janet DiFiore was born and raised in Mount Vernon, New York, where she attended grade school and High School. She attended C.W. Post College, Long Island University

and St. John's University School of Law where she received her Juris Doctor degree. She was admitted to the Bar of the State of New York in 1982.

Judge DiFiore entered public service in 1981 as an Assistant District Attorney in the Westchester County District Attorney's Office remaining there until 1987 and returning in 1994 as Chief of the Office's Narcotics Bureau.

In 1998 she was elected a Judge of the Westchester County Court, presiding over criminal and civil matters and sitting by designation in the Family Court, Surrogate's Court and Supreme Court. She served as a County Court Judge until 2002, when she was elected a Justice of the New York State Supreme Court.

Shortly after her January 2003 swearing in as a Supreme Court Justice, during the administration of Chief Judge Judith Kaye, Judge DiFiore was appointed by then-Chief Administrative Judge Jonathan Lippman to serve as Supervising Judge of the Criminal Courts for the 9th Judicial District. As Supervising Judge, she restructured the case assignment system to bring more efficiency to the management and disposition of criminal cases and led a collaborative effort in the criminal courts of the 9th Judicial District that completely eliminated the backlog of criminal cases that did not meet the Standards and Goals (reportedly the first and only time since the Standard and Goals were established that any Judicial District in New York has done this). Also as the Supervising Judge, Judge DiFiore led the collaborative effort to establish the 9th Judicial District's Mental Health Courts and Sex Offender Courts.

In 2005, Judge DiFiore resigned from the bench and was elected as Westchester County District Attorney. As District Attorney, she served as the chief law enforcement officer of Westchester County, home to nearly one million people

who reflect the broad economic, social, racial and ethnic composition of New York State itself. District Attorney DiFiore headed an office of 235 Assistant District Attorneys, Criminal Investigators and support personnel, prosecuting approximately 30,000 cases per year, with a felony conviction rate that was consistently among the highest in New York State.

Judge DiFiore's law enforcement strategies have addressed the persistent problems of crime and poverty in cities that have been part of New York State's strategic IMPACT and GIVE anti-violent crime funding programs. She has also been at the forefront of establishing innovative education and prevention initiatives to reduce crime. Countywide strategies include targeting crimes involving gang violence, domestic violence, child abuse, elder abuse, identity theft, the environment, animal abuse, and driving while under the influence of drugs and alcohol.

Early in her first term as District Attorney, Judge DiFiore led the multiagency effort to create a Child Fatality Review Team in Westchester County to examine deaths of children that are suspicious or are the result of abuse or neglect, and identify factors that might prevent future child fatalities. Working with partner agencies, the Child Fatality Review Team has worked to improve child safety in the County since 2007.

Also in her first term as District Attorney, then-District Attorney DiFiore was approached by the Innocence Project on behalf of an individual who had been convicted as a teenager in 1990 of the rape and murder of a 15-year old girl in Peekskill, New York. A Westchester County jury had convicted this individual based upon police testimony of a confession by the defendant. Because an FBI laboratory analysis of the evidence recovered from the deceased victim produced a non-matching DNA profile and this exculpatory evidence was admitted at his trial, this individual was not entitled, by statute, to further DNA testing of the sample. Notwithstanding these circumstances Janet DiFiore personally reviewed the case file and insisted on new DNA analysis of the evidence. This new DNA profile matched the profile of an inmate incarcerated for his conviction in another Peekskill murder case. That inmate made a credible confession to the murder. Then-District Attorney DiFiore immediately acted to have the murder and rape convictions vacated and the individual wrongfully convicted released from custody. The District Attorney's Office then secured a conviction of the true murderer. In order to identify and learn from the mistakes that led to this conviction of an innocent man, Judge DiFiore commissioned an independent group of outside experts to review the entire record of the case and at its conclusion, publicly issued the independent commission's report in an effort to contribute to law enforcement's understanding of wrongful convictions.

As the chief law enforcement officer in Westchester County, Judge DiFiore recognized that there was a critical need to coordinate investigative resources and enhance information sharing among Westchester County's 42 local police de-

partments, the County Police, the New York State Police, and the state, federal and regional law enforcement agencies that work in the County. Working with these partners, she led the effort to establish the Westchester Intelligence Center, which supports multi-agency investigations by obtaining evidence through databases, analyzing telephone data, identifying crime trends that cross jurisdictional borders, monitoring the myriad of platforms of social media used by criminals, and serving as a clearinghouse for information for law enforcement.

In 2009, Judge DiFiore was appointed by then-Chief Judge Jonathan Lippman to serve as Co-Chair of the newly created Justice Task Force which examines the causes of wrongful convictions and recommends changes to the criminal justice system to safeguard against such convictions. Judge DiFiore held that position until her confirmation as Chief Judge in 2016.

From 2011 to 2012, Judge DiFiore served as President of the District Attorneys Association of the State of New York, leading the organization of New York State's 62 elected District Attorneys in its work to enhance public safety by setting forth the perspective and experience of New York's prosecutors in the public debates on criminal justice legislation and policy. During her tenure as President she was a lead participant in building support among colleagues for the "all crimes" DNA legislation, which included post-conviction access to DNA testing by defendants that became law.

Also in 2011, then-District Attorney DiFiore was appointed by Governor Andrew Cuomo as the first Chair of the 14-member Joint Commission on Public Ethics, the statewide ethics agency created by the Public Integrity Reform Act of 2011. District Attorney DiFiore led the effort to develop this important Commission from infancy into an efficient 50+ person operation which regulates public officials, state employees, lobbyists, and lobbying clients.

In 2014 Janet DiFiore served as a member of the Governor's Commission on Youth, Safety and Justice recommending reforms to the laws governing the prosecution of young offenders.

On December 1, 2015, Governor Cuomo nominated her to the position of Chief Judge of the Court of Appeals and the State of New York. On January 21, 2016, Janet DiFiore's nomination was unanimously confirmed by the New York State Senate.

In August of 2017, Janet DiFiore was elected to a two year term as a member of the Board of Directors of the Conference of Chief Justices.

Outstanding Pro Bono Volunteers



Caroline Heller
Chair of the Global Pro Bono Program

Caroline J. Heller is a shareholder in the Litigation Practice of Greenberg Traurig's New York office. Caroline focuses her practice on complex commercial litigation and business disputes on a nationwide basis in the fields of professional liability, partnership disputes, securities litigation and entertainment disputes. She is also Chair of the firm's Global Pro Bono program and the Pro Bono Coordinator for the New York office. Since joining the firm in 2004, she has dedicated over 4,100 hours of her time to the pro bono representation of low-income families and

non-profit organizations. Among others, Caroline has represented the parents of children with disabilities seeking appropriate educational programs, unaccompanied minors in immigration proceedings, and victims of domestic violence in family court proceedings.

Since 2006, Caroline has represented low-income parents of approximately 25 children with disabilities who have sought to obtain appropriate special education services for their children from the New York City Department of Education (DOE). These cases are referred to her by Advocates for Children of New York (AFC), a New York City nonprofit, where she also serves as a member of the Board of Directors.

In 2017, Caroline represented four families with children with disabilities, filing complaints alleging that for the 2017-2018 schoolyear, the DOE failed to provide the students with a free appropriate public education in violation of the Individuals with Disabilities Education Act ("IDEA") and New York Education Law, seeking payment for the tuition of specialized private schools for these students.

This year, Caroline also took on the representation of the parents of four medically fragile New York City school students who either had not attended school for 2-3 years, or were at risk of not being able to attend school, because the DOE failed to provide these students with medically necessary nurses to accompany the children to, from, and in school; nurses that DOE had promised to provide.

Caroline also received a favorable decision from the Second Circuit this year in another special education case involving a student with dyslexia who, at 12 years old, still had not been taught how to read by the public school programs in which the DOE had placed him.

In 2016, Caroline represented a number of organizations in amicus curiae briefs submitted to the U.S. Supreme Court in two cases concerning the rights of students with disabilities under the Individuals with Disabilities Education Act. Caroline represented Autism Speaks, on whose behalf she submitted an amicus curiae brief to the Supreme Court of the United States in support of the petitioner in *Fry v. Napoleon Community Schools*. In a decision dated February 22, 2017, the Supreme Court reversed the Sixth Circuit—a victory for Caroline's client—holding that the IDEA does not require exhaustion of state-level administrative remedies when the gravamen of the plaintiff's lawsuit is not related to the denial of free appropriate public education.

Caroline has been a trailblazer in Greenberg Traurig's Pro Bono practice. Under her leadership, in 2017, GT joined the American Bar Association's Homeless Youth Legal Network Pro Bono Initiative, "adopting" homeless youth shelters across the country in order to provide free legal services to youth and young adults. Caroline was also instrumental in a firm wide training program, with more than 200 attorneys and clients participating, led by International Refugee Assistance Project (IRAP). IRAP is an organization committed to helping attorneys and law students develop and enforce a set of legal and human rights for refugees and displaced persons.

Among Caroline's many recognitions for her pro bono service, she received the New York Business Journal's "Women of Influence Award", the New York Law Journal's "Lawyers Who Lead By Example Pro Bono Award" and the President's Pro Bono Award from the First Judicial District of the New York Bar Association.

Caroline received her J.D., cum laude, from Northwestern Pritzker School of Law and her B.A., cum laude, in Political Science from Bryn Mawr College.

Benjamin Ostrer was admitted to practice in New York in 1977 and is also admitted before the U.S. Court of Appeals for the Second Circuit and in the District Courts of the Southern, Eastern and Northern Districts. He is a graduate of Alfred University and New York Law School. He has tried numerous cases to favorable verdicts and has successfully litigated appeals before the New York State Court of Appeals and Appellate Divisions. He regularly accepts pro bono matters on behalf of individuals accused of serious crimes, including *People v. Maragh*, 94 N.Y.2d 569 (2000), which resulted in the adoption of a

new jury charge with respect to juror expertise and the reversal of a homicide conviction; *People v. Pitkin*, (2008) in which he obtained not guilty verdicts of all counts, including Murder 2nd, in an alleged shaken baby diagnosis case. His pro bono efforts also include serving as co-counsel on behalf of Katherine Seeber, in Saratoga County, with Vernon Broderick and Corey Chivers of Weil, Gotshal & Manges, which resulted in vacating a homicide conviction which relied upon falsified evidence at the New York State Police Lab, ending 12 years of incarceration for a young woman; *People v. Seeber*, 94 A.D.3d 1335 (2012). He is currently pro bono counsel in *People v. Carlson*, defending a man in connection with the shooting death of an admitted rapist who had been eluding capture by law enforcement.

Ben currently serves on the Board of the Criminal Justice Section of the NYSBA and was the recipient of the section's Charles F. Crimi Award in 2016. He is a board member of the Legal Aid Society of Orange County and past president of the N.Y. State Association of Criminal Defense Lawyers. His firm, Ostrer Associates, P.C., is located in Chester, Orange County, New York.

In the first 11 months of 2017, New York office lawyers and summer associates' pro bono work equaled 6.8% of billable hours and totaled 73,035 hours. After adding in legal assistant pro bono work, the 11 month total hours were 86,240. Firmwide, Skadden attorneys, summer associates, and legal assistants recorded 218,880 hours of pro bono legal work for the first 11 months of 2017. The lawyer plus summer associate pro bono percentage of billable time in Skadden's domestic offices was 8.0% for the first 11 months of 2017.

Deeply ingrained in the firm's culture, pro bono legal work provides vital assistance to a wide variety of individuals and organizations in need of legal assistance. Skadden attorneys regularly assist those seeking asylum in the United States and elsewhere in their attempts to escape persecution due to religious or political beliefs or sexual orientation.
