

**INTERMUNICIPAL AGREEMENT BETWEEN THE [VILLAGE/TOWN] OF [NAME
OF CITY/VILLAGE/TOWN], NEW YORK AND BROOME COUNTY, NEW YORK,
REGARDING THE DELEGATION FROM THE [VILLAGE/TOWN] TO THE COUNTY
TO ISSUE SPECIAL HAULING PERMITS FOR OPERATION ON [VILLAGE/TOWN]
ROADS BY VEHICLES THAT EXCEED THE LIMITS OF SECTION 385 OF THE NEW
YORK STATE VEHICLE AND TRAFFIC LAW FROM THE [VILLAGE/TOWN] TO
THE COUNTY**

THIS AGREEMENT, made and entered into this [date], between the [Village/Town] of [name of Village/Town], a municipal subdivision of the State of New York, situated in Broome County [Post Office Address], with offices at [mailing address] (the "[Village/Town]"), and The County of Broome, a municipal subdivision of the State of New York situated in New York State, with offices at the Broome County Office Building, mailing address _____, New York _____ (the "County")

WHEREAS, both parties currently own and are responsible for the maintenance of various public roadways, highways and sidewalks within their respective municipalities, and

WHEREAS, both parties currently have Local Laws in their respective municipalities for the issuance of Special Hauling Permits under Section 385(15) of the New York State Vehicle and Traffic Law allowing vehicles which exceed the weight or dimensional limits under Section 385 to operate on each municipalities' respective public roadways and highways, and

WHEREAS, it is the desire of the [Village/Town] of [name of Village/Town] and Broome County to enter into this Agreement, pursuant to General Municipal Law § 119-o, which will allow the [Village/Town] to delegate to the County the authority to promulgate and receive, on behalf of the [Village/Town], applications for those Special Hauling permits that would be issued by the [Village/Town] for use on [Village/Town] roadways and highways. Under this Agreement, the County would further have the authority to review all Special Hauling Permit applications received on behalf of the [Village/Town], and if satisfied with the application, to issue a Special Hauling Permit on behalf of the [Village/Town].

NOW, THEREFORE, IT IS HEREBY AGREED, by [City/Village/Town] and Broome County as follows:

1. The [Village/Town] hereby delegates to the County Commissioner of Public Works (herein "County Commissioner"), acting on behalf of the County, the authority to promulgate an application form for those requesting a Special Hauling Permits which would allow applicants to operate or move a vehicle or a combination of vehicles, the weights and dimensions of which exceed the limitations provided in Section 385 of the New York State Vehicle and Traffic Law on [Village/Town] roadways or highways. The application will be consistent with the requirements of [Village/Town] Local Law No. ____ of 20__ and Broome County Local Law No. ____ of 20__, and the application form will include:
 - a. A list of [Village/Town] highways to be used as hauling routes, if any, by the permit holder.
 - b. Copies of valid New York State Vehicle Registrations for each vehicle.
