

#### Thank You, Empire State Counsel®

- The volunteer attorneys at Shearman & Sterling participate in a limited scope representation project in the New York City Family Court in Kings and New York counties impact families in crisis.
- Participants assist the Volunteer Lawyers Projects sponsored by the Queens, Brooklyn, Bronx, Richmond, Nassau and Suffolk County Bar Associations.
- They provide assistance through the

New York County Lawyers Association's uncontested divorce project, its consumer bankruptcy clinic, its legal counseling clinic and its U.S. Tax Court Calendar Call Project.

• And, they serve the City Bar's Consumer Bankruptcy Project, its Federal Pro Se Legal Assistance Project, and its legal clinic for the homeless.

Whether serving as a volunteer attorney of the day in the Volunteer Lawyers Project of Onondaga County Homeless Advocacy and Prevention Program or participating in a domestic violence clinic in St. Lawrence County or New York County, Empire State Counsel® play an important role in helping those in greatest need.

One of my goals during my term as president of the New York State Bar Association is to remind people about the good things that lawyers do and the important role we play in peoples' lives each and every day. There are a lot of lawyer jokes, but when people are in trouble and need help, they don't call comedians - they call us. 

**Sharon Stern Gerstman**President, New York State Bar Association

I spent the majority of my career working in Supreme Court in Erie and Niagara Counties. When I began to work for the court, there was an absolute prohibition on doing any outside practice, including pro bono. In the 1990's, that rule changed to permit employees of the Unified Court System to render legal services through a pro bono provider, so long as the employee used annual leave time and so long as there was no conflict with the employee's legal position within the courts. As a judicial law clerk in Supreme Court, almost everything presented a conflict, since most matters could find their way to Supreme Court. One exception was the Attorney of the Morning program, run by the Volunteer Lawyers Project of Erie County, in Buffalo City Court. There, I could represent tenants facing eviction, and if any matter was appealed, it would go to County Court and then the Fourth Department, avoiding any conflict.

I must admit I was skeptical at first. I knew next to nothing about the RPAPL and I wondered if I could really be helpful to the tenants I would be representing. But, the VLP promised training, which qualified for MCLE credit, and so I signed up — free CLE for a commitment to be Attorney of the Morning twice. The training was given by an expert in poverty law, who walked us through the applicable provisions and provided a user-friendly "cheat sheet" of likely issues and the applicable law. And so, armed with this training and the cheat sheet, I went to Buffalo City Court. I was assigned 6 cli-

ents, who had cleared the eligibility and conflicts tests given by a VLP paralegal. For some of the clients, I found irregularities in the summary proceeding petition or procedure, for others I negotiated to buy some time before they left voluntarily. By the end, I had done something helpful for each of the 6 clients — either by settlement or by successful motion to dismiss the petition. I was no longer skeptical — I was now an Attorney of the Morning junkie. Over the years, I volunteered as much as I could — often as a standby, in case another volunteer had to cancel.

The point of sharing my pro bono story with you is to convince you that EVERYONE can do pro bono. In my case, it was for a few hours of limited scope representation, when I had the time. Even though I knew nothing about the law or practice area, the training provided me all that I needed to be a good advocate. Even though I was neither encouraged nor supported by my employer to take the matters on, it was well worth it to me to take annual leave for those few hours. It gave me an opportunity to stand before the court and argue a case (something missing in my day job), it allowed my interaction with other lawyers and judges as an advocate, and it gave me tremendous satisfaction to actually make a difference in the lives of my clients. You will find all of that as a continuing theme in the stories of the Empire State Counsel — lawyers inspired to provide at least 50 hours of service per year.

For many of you, you may find that

your firm encourages and supports your efforts to take matters on. Or you might be able to find a client who needs services in your area of law. For younger lawyers, taking a pro bono matter may give you experience in court and with more seasoned colleagues from whom you will learn a lot. For all of you, you will find your service fulfilling, educational and enjoyable. So, do the public good.

There are unlimited opportunities in types of programs and types of cases and clients. Start by contacting your firm's pro bono coordinator or your local volunteer lawyers project. If you are a member of a NYSBA section, you may also find a clinic at which you can volunteer — knowing that the matters will fall within your expertise. But don't be afraid to learn something new. The trainings are incredibly helpful — and who knows — you might be drawn to a new area of law.

Many of you are deeply concerned about the treatment of immigrants or proceedings involving undocumented children. You can provide pro bono assistance — take the training on immigration law, or provide assistance to these individuals for their other legal problems. Use the NYSBA pro bono portal to match you with programs providing such assistance or contact your local VLP directly to volunteer.

Thanks to all of you for all the pro bono you do, especially those who have Empire State Counsel status. For those of you still sitting on the dock, what are you waiting for? Jump in, I promise you'll enjoy the swim.

# Caroline Heller Counsel and Chair of the Global Pro Bono Program Greenberg Traurig LLP

Caroline Heller is a shareholder in the Litigation Practice of Greenberg Traurig's New York office. Caroline focuses her practice on complex commercial litigation and business disputes on a nationwide basis in the fields of professional liability, partnership disputes, securities litigation and entertainment disputes. She is also Chair of the firm's Global Pro Bono program and the Pro Bono Coordinator for the New York office. Since joining the firm in 2004, she has dedicated over 4,100 hours of her time to the pro bono representation of low-income families and non-profit organizations. Among others, Caroline has represented the parents of children with disabilities seeking appropriate educational programs, unaccompanied minors in immigration proceedings, and victims of domestic violence in family court proceedings.

In 2017, Caroline represented four families with children with disabilities, filing complaints alleging that for the 2017-2018 school year, the DOE failed to provide the students with a free appropriate public education in violation of the Individuals with Disabilities Education Act ("IDEA") and New York Education Law, seeking payment for the tuition of specialized private schools for these students.

This year, Caroline also took on the representation of the parents of four medically fragile New York City school students who either had not attended school for 2-3 years, or were at risk of not being able to attend school, because the DOE failed to provide these students with medically necessary nurses to accompany the children to, from, and in school; nurses that DOE had promised to provide.

Caroline also received a favorable decision from the Second Circuit this year in another special education case involving a student with dyslexia who, at 12 years old, still had not been taught how to read by the public school programs in which the DOE had placed him.

Caroline has been a trailblazer in Greenberg Traurig's Pro Bono practice. Under her leadership, in 2017, GT joined the American Bar Association's Homeless Youth Legal Network Pro Bono Initiative, "adopting" homeless youth shelters across the country in order to provide free legal services to youth and young adults. Caroline was also instrumental in a firm wide training program, with more than 200 attorneys and clients participating, led by International Refugee Assistance Project (IRAP). IRAP is an organization committed to helping attorneys and law students develop and enforce a set of legal and human rights for refugees and displaced persons.

Caroline received her J.D., cum laude, from Northwestern Pritzker School of Law and her B.A., cum laude, in Political Science from Bryn Mawr College.

## Benjamin Ostrer Ostrer Associates PC

Benjamin Ostrer was admitted to practice in New York in 1977 and is also admitted before the U.S. Court of Appeals for the Second Circuit and in the District Courts of the Southern, Eastern and Northern Districts. He is a graduate of Alfred University and New York Law School. He has tried numerous cases to favorable verdicts and has successfully litigated appeals before the New York State Court of Appeals and Appellate Divisions. He regularly accepts pro bono matters on behalf of individuals accused of serious crimes, including People v. Maragh, 94 N.Y.2d 569 (2000), which resulted in the adoption of a new jury charge with respect to juror expertise and the reversal of a homicide conviction; People v. Pitkin, (2008) in which he obtained not guilty verdicts of all counts, including Murder 2nd, in an alleged shaken baby diagnosis case. His pro bono efforts also include serving as co-counsel on behalf of Katherine Seeber, in Saratoga County, with Vernon Broderick and Corey Chivers of Weil, Gotshal & Manges, which resulted in vacating a homicide conviction which relied upon falsified evidence at the New York State Police Lab, ending 12 years of incarceration for a young woman; People v. Seeber, 94 A.D.3d 1335 (2012). He is currently pro bono counsel in People v. Carlson, defending a man in connection with the shooting death of an admitted rapist who had been eluding capture by law enforcement.

Ben currently serves on the Board of the Criminal Justice Section of the NYSBA and was the recipient of the section's Charles F. Crimi Award in 2016. He is a board member of the Legal Aid Society of Orange County and past president of the N.Y. State Association of Criminal Defense Lawyers. His firm, Ostrer Associates, P.C., is located in Chester, Orange County, New York.

After adding in legal assistant pro bono work, the 11 month total hours were 86,240. Firmwide, Skadden attorneys, summer associates, and legal assistants recorded 218,880 hours of pro bono legal work for the first 11 months of 2017. The lawyer plus summer associate pro bono percentage of billable time in Skadden's domestic offices was 8.0% for the first 11 months of 2017.

Deeply ingrained in the firm's culture, pro bono legal work provides vital assistance to a wide variety of individuals and organizations in need of legal assistance.
