"I am the first generation lawyer in my family. My parents emigrated from Mexico in the late 50's. My dad came here as part of something called the Bracero program, a Mexican migrant farm worker program. The day I graduated law school, the thing I remember most of that day was my parents being there and my father, who was only able to attend the third grade in Mexico, standing in Rockefeller Chapel, a very impressive structure, a big building, and see me walk up and obtain my degree and hear his last name being called in an institution like that, which in his wildest dream wouldn't have been possible when he was growing up in Mexico."


MINORITY HIGH SCHOOL STUDENTS SHOULD BE EXPOSED TO THE LEGAL PROFESSION AND ENCOURAGED TO BECOME ATTORNEYS

Although strides have been made, individuals of color continue to be underrepresented in the legal profession. The Young Lawyers Division of the American Bar Association (the "YLD") is committed to increasing diversity in the legal profession by assisting and encouraging individuals of color to become attorneys. Although there are many existing diversity initiatives focused on law school and college students, there are insufficient resources targeting high school students of color. The YLD believes that it is crucial to encourage students at an early age to consider legal careers so that they can begin to prepare themselves accordingly.

Many young individuals of color have few or little opportunities to be favorably exposed to the legal profession and may have few financial opportunities to prepare themselves for a career as an attorney. Students may not have family members who are in the legal profession or have role models who are in the legal profession. Therefore, additional time and effort must be devoted to educating students of color about the profession of law and encouraging them to consider law as a career.

To address this gap, the YLD has developed a project focused on educating students of color about the legal profession and exposing them to actual attorneys who have overcome many of the challenges that the students may face. The Project emphasizes the importance of law in society and introduces students to the important, rewarding and diverse careers a law degree can provide. The Project also highlights attorneys and judges of color who have played a crucial role in obtaining and enforcing civil rights and in ensuring opportunities for members of racial minority groups. Finally, the Project stresses the importance of education and instructs students on the steps they need to take to go to law school and become lawyers.
